No.11/3/2022-PJ6/ 1/420981/2022.-In exercise of the powers conferred by section 15 and section 23-C of the Mines and Minerals (Development and Regulation) Act, 1957, (Central Act 67 of 1957), and all other powers enabling him in this behalf, the Government of Punjab is pleased to issue standardized Application form, Certificates, weighment slip, monthly return form and stock register under the "Punjab Crusher Policy 2022".

- i. *Mineral Dealer License Application Form:* All the suppliers/dealers of minor mineral and processed material in the state shall be registered on the online portal. This Mineral Dealer License Application Form shall be submitted to the department through online mode by the suppliers/dealers to apply for registration. The standardized format of Mineral Dealer License Application Form is at Annexure 'A'.
- ii. *Certificate of Mineral Dealer License:* This Registration Certificate of Mineral Dealer License shall be issued through online mode by the Department. The standardized format of Mineral Dealer License is at Annexure 'B'.
- iii. *Stock Register to be maintained by a Mineral Stocking Dealer:* Stock Register shall be maintained through online mode by a Mineral Stocking Dealer. The standardized format of Stock Register is at Annexure 'C'.
- iv. *Application Form for Crusher/Screening Plant Registration:* This Application Form shall be submitted to the department through online mode by the crusher owner to apply for Crusher/Screening Plant registration. The standardized format of this Application Form is at Annexure 'D'.
- v. *Crusher/Screening Plant Registration Certificate:* This Certificate of Crusher/Screening Plant Registration shall be issued through online mode by the Department. The standardized format of Mineral Dealer License is at Annexure 'E'.

- vi. *Crusher/screening plant Weighment Slip (Form 'Q'):* The weighbridge shall be installed in the premises of stone crusher. The weight of processed material shall be captured on weighbridge integrated with online portal of department. The weighment slip for processed material shall be issued in Form 'Q'. The standardized format of weighment slip is at Annexure 'F'.
- vii. *Monthly Crusher/Screening Plant Return (Form 'C'):* The crusher shall be accountable for sources of minerals for crushing and shall satisfy the concerned Mining Officers while producing the details of source in monthly return in Form 'C' through online portal of department. The standardized format of Monthly crusher/screening plant return is at Annexure 'G'.
- viii. *Stock Register to be maintained by a Crusher/Screening Plant:* Stock Register shall be maintained through online mode by a Crusher owner. The standardized format of Stock Register is at Annexure 'H'.

- 2. The crusher owner/Screening plant owner shall not indulge in any sort of illegal mining of any minor mineral.
- 3. The crusher owner/Screening plant owner shall abide by with the provisions of the Punjab Crusher Policy 2022, the Punjab Minor Mineral Rules, 2013, the Mines and Minerals (Development and Regulation) Act, 1957 and all orders/directions issued by the State Government from time to time made in regard of operation of Stone Crusher/Screening Plant.

- 4. The crusher owner/Screening plant owner shall allow the officer authorized by the department to enter the premises of my Stone Crusher/Screening Plant for checking or assessment purposes.

prescribed, giving details of total quantity of minerals crushed, electricity consume, power generated in case of captive power generated run crusher, fuel consumption in case of diesel run crusher, number of labour employees and wages paid etc.

- 12. Free access should be given to the officer/official of the department of Mines and Geology, Punjab for the verification of plant & machinery, source/supply of raw material, sale record and stocks of raw material and finished goods.
- 13. The crusher Owner/screening plant owner shall immediately report to the Deputy Commissioner and District Mining Officer of the District concerned about any accident which may take place during the course of crushing operation in serious bodily injury.
- 14. The crusher Owner/screening plant owner shall not pay wages less than the minimum wages prescribed by the Centre or State Government from time to time under the Minimum Wages, Act 1948, to the workers employed in the crushing unit.
- 15. In the event of non-observance of the condition in the registration certificate, the registration of stone crusher shall be terminated as per period specified in Punjab Crusher Policy 2022 and the consent of Punjab Pollution Control Board, if any, shall be invalid.
- 16. The crusher Owner/screening plant owner must adhere to all clauses of the Punjab Crusher Policy 2022 (or as amended from time to time) and all the rules and regulations or other directions of the Department of Mines and Geology, Punjab, made in regard to operation of Stone Crusher/Screening Plant
